Social Host Ordinance	Shelly contacted Town Councilwoman Gina LeClair to follow up on what, if anything, has been done on local social host ordinance or laws. The Town/village does not currently have any social host restrictions. Social hosting is an adult providing alcohol to minors. The Coalition spoke to the Town Board about this a few years ago, but nothing was completed. Gina was going to speak to the Town's attorney. The Coalition may want to address this issue since the PNA (needs assessment) indicated that most students who get alcohol stated that they get it from older adults. Sub-Committee Updates PFS	James briefly updated the group on FACE and Super-power Your Parenting Initiatives	
Data Committee	Shelly invited anyone who is interested to the I Love Data Committee happening Thursday, May 3rd from 12-1 at the High School. Data from the most recent PNA is being reviewed.	
Sticker-Shock	Kara updated the group on the most recent sticker-shock campaign. Five (5) local stores participated in allowing Kara and students to put stickers on alcohol reminding people to not give alcohol to minors.	
Sustainability	We had a discussion about the need to think about how to keep the CCFW viable once the DFC funding is completed (ends in 9/18). We have applied for funding for another 5 years, but will not know whether or not we will get this funding until after the current funding runs out. The PFS grant is completed in 9/19. There is no second round of funding for that grant. We will be discussing this at our Annual Retreat. Donna and Bill will also be inviting their Development Directors to do a short piece on fundraising.	
Fundraising	There are 2 fundraising events already set – one on 5/8 at Little Caesar's in SGF and one at the Texas Roadhouse in Queensbury. Go eat and tell all your friends so we get 10% of the proceeds. This will specifically help with after-prom expenses.
